

I. PERFORMANCE WORK STATEMENT

- A. The purpose of this firm fixed price contract is to for once a year preventive maintenance (PM) of USG split A/C units, once every four months preventive maintenance of USG A/C split units, inspections, replacements and new installation services of USG split A/C units, at the compound and Residences in charge of the US Embassy in Asuncion in accordance with Attachment A.
- B. The contract will be for a one-year period from the date of the contract award, with **4** one-year options.
- C. The Government will order all work by issuing task orders.
- D. This is an indefinite-delivery indefinite-quantity type contract under which may be placed firm-fixed price task orders.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

- (f) *If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.*
- (g) *The COR will consider complaints as resolved unless notified otherwise by the complainant.*
- (h) *Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.]*

MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of **10 orders**. This reflects the contract minimum for this period of performance. The amount of all orders shall not exceed **600 orders**. This reflects the contract maximum for this period of performance.”

III. INSURANCE

1. **AMOUNT OF INSURANCE.** The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

4. 8. Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) days after contract award. The

Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

16. The contractor is responsible to provide supplies & equipment to perform above services.
